# FUND'S 2006 YEAR AT A GLANCE

December 31, 2006 completed another successful year for the Newman Fund. Newman Medals were awarded to 11 students, bringing the total to 186 medals awarded at nearly 50 schools of architecture, engineering and music throughout the world since the program began in 1985.

The deadline for applications for the 2007 Schultz Grant has been extended to June 1, 2007 and it is expected to be awarded in late summer. Five student teams received Harry Wenger prizes in 2006 for their meritorious design work juried and displayed at the ASA Student Design Competition held in the spring at Providence, RI.

2006 was another stellar year for the Fund. The appreciation of the Advisory Committee is extended to students, teachers, consultants, as well as other professionals and supporters whose extraordinary voluntary efforts make the work of the Fund possible and thoroughly enjoyable. # SPOTLIGHT FUND ADVISOR BILL CAVANAUGH

We are pleased to announce that Bill Cavanaugh, Co-Chairman of the Newman Student Award Fund, was awarded the Wallace Clement Sabine Medal of the Acoustical Society of America, presented at a meeting of the Acoustical Society in Honolulu, HI on December 1, 2006. The Sabine Medal is the highest award given by the Acoustical Society in the field of Architectural Acoustics. The citation reads for contributions to the practical application of architectural acoustics in building design and to education in architectural acoustics.

Bill is the thirteenth medalist since the Sabine Medal was introduced in 1957. Previous recipients have included Vern Knudsen, Leo Beranek and Russell Johnson.

Bill studied Architecture at MIT and received his B. Arch. in 1951. He was introduced to architectural acoustics at MIT in 1949, when he took Professor Richard Bolt's introductory course, where Robert Newman was serving as teaching assistant, and the Advanced Problems in Acoustics course at the MIT Acoustics Laboratory.

After military service during the Korean War, Bill began his career in acoustics when he joined Bolt, Beranek and Newman in February 1954. In 1975 he joined with Gregory Tocci to found Cavanaugh Tocci Associates, now in its 31st year of operation. Bill's principal interests include the development of criteria for acceptable acoustical environments in buildings and in teaching architectural acoustics. In 1994, he was awarded the Acoustical Society's Distinguished Service Citation, and has served as President of the Institute of Noise Control Engineering of the USA (INCE/USA) and the National Council of Acoustical Consultants (NCAC). Bill has written and edited many technical papers and books, including Architectural Acoustics: Principles and Practice (Wiley, 1998).

Bill was one of Bob Newman's many friends who, soon after Bob's untimely death in 1983, sought a way to carry out Bob's vision that a good basic course in architectural acoustics be available at schools throughout the world. The Newman Fund has done much to achieve this objective. The Fund is one of Bill's favorite extracurricular activities that he intends to continue for the foreseeable future.



# 2006 STUDENT DESIGN COMPETITION RESULTS

The 2006 Student Design Competition, sponsored by the ASA's Technical Committee on Architectural Acoustics (TCAA), with the support of the National Council of Acoustical Consultants (NCAC) and the Newman Student Award Fund, was judged at the 151<sup>st</sup> ASA meeting in Providence, RI in June, 2006. The competition included posters from fourteen student teams.
